PACIFIC PROPERTY ASSETS (PPA)
RENTAL CRITERIA

Please read and sign

INCOME: Applicants must show a gross monthly income equal to three (3) times the monthly rent; have current verifiable employment, or have their last 3 pay stubs showing year-to-date earnings or their 3 most recent bank statements.

SELF-EMPLOYED applicants must provide a copy of their most recent federal tax return showing business and personal income for that tax year. Their income must meet all other qualifications.

ROOMMATES may combine their gross incomes for a total of four (4) times the monthly rent. They must meet all other criteria on their own.

STUDENTS: Will need to provide proof of current enrollment at an accredited educational institution, source of monthly income, and will also need to provide a co-signer who has a gross monthly income four (4) times the monthly rent.

RENTAL HISTORY: Any negative rental history, which includes, but is not limited to, evictions, skips, or judgments that are more than one (1) year old will require a double security deposit. Any unpaid or unsatisfied skips, evictions, or judgments will be denied, unless regular payment schedule can be shown.

CREDIT HISTORY: Applicant must have a credit score of 550. Credit reports that show more than \$10,000 in past due debt, which includes but is not limited to, charge-offs and collection accounts, will require a double security deposit. Medical debt is excluded.

CO-SIGNERS: Must have an excellent credit rating, 650 or higher and meet all other criteria. Applicants requesting a co-signer will require a double security deposit.

CRIMINAL HISTORY: PPA follows the guidelines of the Crime-Free Multihousing Program. A felony conviction, even if it was plea-bargained down to a misdemeanor, is an automatic denial. Misdemeanors that could be considered a potential threat to the safety of the community will be an automatic denial. We reserve the right to decide if the misdemeanor is to be a denial.

APPLICATION FEE: \$40.60 for each applicant over age 18 or per married couple. If completing this application on line, please mail the original with the application fee. We do not accept incomplete applications. We must see a valid photo state I.D. and social security card, or valid work Visa with the application before move-in.
